Clarification questions and notes report.

A Framework Tender The Supply of Storage Batteries and Engineering-Procurement-Construction (EPC) Services of Battery Storage Power Stations

Bidders are kindly requested to note that after consideration of circumstances, including feedback received from some bidders, the Submission Deadline for this Tender is extended to March 16, 2022.

Presented below are the clarifying questions / notes about the tender and their correlating answers, with referral to the relevant section within the tender:

- 1. The answers and notes presented below are biding to all contending vendors, are an inseparable part of the tender documents, and overpower the phrasing of the tender.
- 2. There shall be no reliance on any interpretation given orally or in writing or in any other format by members of the office or the tender committee, as far as one was given, in any shape or form. All interpretations and clarifications are as specified in this document and the additional clarification documents which will be sent by the tender committee, if such additional documents are published. This document shall be considered as part of the conditions of the tender, and is thus subject to the same rules as all other tender documents.



- 3. any case of a lack of a response from the committee to any question or remark or any details of a question or remark shall not be considered as an agreement to the asker's instructions or as an alteration of the tender conditions.
- 4. As far as this document contains notes, questions and answers regarding interpretation of the law, they shall not serve as a substitute for qualified legal counsel, and he who relies on them does so under his own responsibility.
- 5. It shall be clarified that the phrasing of the questions seen below may not be identical to the phrasing used by those who submitted the questions, and that not every question has necessarily been answered.
- 6. Unless it is said to be otherwise, all terms and phrases used in this document will have the definitions specified in the tender documents.
- 7. In addition to the questions and answers detailed below, the company hereby announces an updated phrasing of the following sections of the tender:

Section 6.7.1 - In place of the original wording, the new section is:

The bidder has managed successfully, or is an affiliate of an entity which has managed successfully, at least two (2) projects in the field of energy infrastructure (for example: natural gas facilities, solar energy, biogas, energy storage, hydroelectric pumped storage etc.), the value of each project is no less than US \$ 5 million, during the period of three (3) years preceding the Submission Deadline.

For the purposes of this section, the phrase "managed successfully" shall have the following meaning: preliminary planning including issuance of permits; final planning; construction of a fully operational system, and provision of an initial warranty period for the client.

Section 6.8: The following sentence shall be added: Experience may be presented in accordance with Section 6.5, 6.6 / 6.7 by a subsidiary of the bidder provided that the bidder holds at least 50.1% of the subsidiary.



Annex B Section 9 - In place of the original wording, the new section is:

We understand that our bid comprises a representation that we meet the criteria set forth in Section 6.6/6.7 of the Invitation to Bid, and that all documents submitted with our bid in this Tender (including documents submitted previously and referred to in this bid), including the undertakings, confirmations and acknowledgments made or described therein or herein, are true, valid, and of continued effect in all material ways, unless otherwise indicated in our bid, and are deemed repeated until notification of the award of contract, unless and to the extent updated by written notice as per the Terms of Tender.
