

## Tender No. PD24000566 (the "Tender")

Energy Infrastructures Ltd. / Oil Products Pipeline Ltd. (hereinafter the "Company") seeks to receive bids ("Bids") from qualified potential bidders ("Bidders") complying with the preliminary conditions stated in the tender documents available on the Company's website at <a href="https://www.pei.co.il">www.pei.co.il</a> (the "Tender Documents"), for the purchase by the Company of Steel Pipe and Fittings as specified in Bill of Quantities attached hereto (the "Goods"), and by manufacturer(s) meeting certain parameters, all as specified in the Tender Documents (the "Goods").

This notice is provided for the convenience of Bidders. It is not intended to express or be referred to in the interpretation of the binding terms and conditions of the Tender and/or the Contract, which terms and conditions shall be solely as expressed in the Tender Documents. Capitalized terms in this notice not otherwise defined herein have the meanings ascribed to those terms in the Tender Documents.

- The supply of Goods will be DDP to ASHKELON warehouse (Incoterms 2010) by
  no later than 90 days following the winning bidder's notification of award (the
  "Delivery Date"). It is emphasized that any delay in supply of Goods which
  deviates from this deadline will be considered a fundamental breach of contract,
  and will cause the supplier to be liable for liquidated damages as described in the
  Contract.
- 2. The Tender Documents include the following requirements:
  - 2.1 The Goods must meet the requirements of the Bill Of Quantities in their entirety, to the Company's satisfaction.
  - 2.2 The Goods must be manufactured (including coating) either (a) by an Approved Manufacturer (as listed in the Tender Documents); or (b) by a manufacturer which successfully manufactured and supplied, during the 5 years preceding the Submission Deadline, pipe and fittings manufactured according to the ASTM B36.10 A106 GrB and ASME B16.5 A-105 standard in an aggregate value of not less than 2,700,000 EURO or 2,925,000 USD.
    - 2.3 The Bidder's net shareholders' equity as of 31 December 2022 must be positive.
    - 2.4 The Bidder must either: (a) be or be an affiliate of an Approved Manufacturer; or (b) have successfully supplied pipe conforming to the ASTM B36.10 A106 GrB and ASME B16.5 A-105 standard during the five years preceding the Submission Deadline, of an aggregate minimum value of NIS 7,000,000 USD 1,950,000 , or € 1,800,000.
    - 2.5 If the Bidder is an Israeli person or entity, it must possess valid approvals pursuant to the provisions of the Public Bodies Transactions Law, 5736-1976.



- 3 Bidders must attach to their Bids all documents proving fulfillment of the above preliminary conditions, as specified in the Tender Documents.
- 4 Bids must be placed in the Company's tender box, at the Company's offices at 3 Hasadnaot Street, Herzeliya Industrial Zone 46120, ISRAEL, or received electronically in the inbox of the Company's dedicated email address at <a href="tender566-24@pei.co.il">tender566-24@pei.co.il</a>, by no later than <a href="tender566-24@pei.co.il">May 1st at 23:59</a>.
- 5 The Tender Documents are available on the Company's website (www.pei.co.il). Potential Applicants/Bidders are instructed to register at the Company's website in order to receive updates, announcements, clarifications etc. regarding the Tender. Said registration shall be the responsibility solely of the Applicants/Bidders, and all notices, updates, announcements and/or clarifications made available to registered Applicants/Bidders thereby shall be deemed received by all Applicants/Bidders upon such publication.
- 6 The Company does not undertake to accept any Application/Bid, and reserves the right to reject any Application/Bid or all them, and does not undertake to enter into an engagement with the lowest Bidder.
