Request for Clarification (2) - Questions and Answers

The following is a response to clarification requests received with relation to the Tender. This document forms an integral part of the Tender Documents.

Capitalized terms shall have the meaning ascribed to them in the Tender Documents.

It shall be clarified that the phrasing of the questions seen below may not be identical to the phrasing used by those who submitted the questions, and that not every question has necessarily been answered.

Question No. 1: To our understanding, the Mandatory Tenders Regulations (Preference for Israeli Made Goods) 5755-1995 should apply in relation to the Tender.

Clarification to Question No. 1: The Mandatory Tenders Regulations (Preference for Israeli Made Goods) 5755-1995 (hereinafter "Preference of Israeli made Goods Regulations") will apply in relation to the Tender, as detailed below:

As part of the consideration of the bids, preference will be given to the relevant items in the bids to which the Preference of Israeli made Goods Regulations apply (hereinafter: "Product" or "Item" and "Preference", respectively).

Preference will be given in relation to goods (as opposed to services). Accordingly, a bidder who wishes to receive a preference in relation to a certain item in the bid form, is required to mark this on the bid form in relation to each item for which the preference is requested, and shall attach to its bid the statement and accountant's declaration attached hereto as Annexes 1-2.

For the avoidance of doubt, it is clarified that the Company will be entitled not to give preference to a bidder who has marked a certain item as an item for which preference is sought without attaching the required statements and confirmations, or alternatively attached incomplete statements and confirmations as required, or contact the

aforementioned bidder for clarification and/or completions in relation with the aforementioned statements and confirmations, all at its sole discretion.

It is hereby clarified that as specified in the Tender Documents, this document forms an integral part of the Tender Documents, and the bidders are required to submit it, dully executed, together with the submission of the other Tender Documents.
